Privacy Policy

This website <u>www.happyness.net</u> ("**Website**") is owned and operated by the management of Arthimpact Finserve Pvt Ltd, operating under the brand name of **HAPPY**, (hereinafter referred to as "**Happy**", which expression shall mean and include its affiliates, successors and permitted assigns). Happy provides services to the Users through the Website and is committed to protecting and respecting the privacy of the Users.

This Privacy Policy ("Policy") governs how the Happy and/ or its affiliates (collectively, "we" and "us" and "our") process, use, collect, disclose, transfer, store and retain our User's ("you" and "your") information.

"User(s)" shall mean and include all individuals, companies and private organisations that visit the Website and provide information to Happy through any of the modes referred to in the clause on "Collection of Information" below.

In the course of using this Website or availing the products and services vide the online application forms and questionnaires, We may become privy to the personal information of our Users, including information that is of a confidential nature.

We are strongly committed towards protecting the privacy of our Users and has taken all necessary and reasonable measures to protect the confidentiality of the User information and its transmission through the World Wide Web. We shall not be held liable for disclosure of the confidential information if such disclosure is in accordance with this Policy or in accordance with the terms of any agreements entered into with the Users.

COLLECTION OF INFORMATION

During the use of the Website, we may collect and process such information from the Users, including but not limited to the below mentioned:

- Information that the Users provide to us by filling in forms on the Website. This includes contact information such as name, email address, mailing address, phone number, financial information, if any, unique identifiers such as user name, account number, password and preferences information such as favourites lists and transaction history;
- Information that the Users provide when the Users write directly to us (including by way
 of e-mail);
- Information that the Users provide to us over telephone. We may make and keep a record of the information shared by the Users with us;
- Information that the Users provide to us by filling surveys;
- Information relating to logs is automatically reported by the User's browser each time
 the User accesses a web page. When the User uses the Website, our servers
 automatically record certain information that the User's web browser sends whenever
 the User visits any website. These server logs may include information such as the User's
 web request, Internet Protocol (IP) address, browser type, referring/exit pages and

YOUR CONSENT

By using the Website and/ or by providing your information, you consent to the collection and use of the information you disclose on the Website in accordance with this Privacy Policy, including but not limited to your consent for collecting, using, sharing and disclosing your information as per this privacy policy.

If we decide to change our privacy policy, we will post those changes on this page so that you are always aware of what information we collect, how we use it, and under what circumstances we disclose it.

NON-DISCLOSURE

We pledge that we shall not sell or rent Users' personal details to anyone. We will protect every bit of the Users' business or personal information and maintain the confidentiality of the same. With this seal of trust, We make our services available to the Users for assessment and analysis that include credit and behaviour scoring, market and product analysis.

Information so collected, may be used in the following ways:

- We may disclose Users' information to governmental and other statutory bodies who have appropriate authorisation to access the same for any specific legal purposes.
- We may disclose Users' information if it is under a duty to do so in order to comply with any legal obligation, or in order to enforce or apply the Terms of Use (displayed on the Website), or to protect the rights, property or safety of Happy, its Users or others. This includes exchanging information with other companies / agencies that work for fraud prevention and credit reference.
- We may disclose Users' information to its agents under a strict code of confidentiality.
- We may disclose Users' information to such third parties to whom it transfers its rights and duties under the customer agreement entered into with the Users. In such an event, the said third parties' use of the information will be subject to such confidentiality obligations as contained in this Policy.
- We may disclose Users' information to any member of its related or group companies including its subsidiaries, its ultimate holding company and its subsidiaries, as the case may be.
- In the event that Happy sells or buys any business or assets, it may disclose the Users' information to the prospective seller or buyer of such business or assets. User, email and visitor information is generally one of the transferred business assets in these types of transactions. We may also transfer or assign such information in the course of corporate divestitures, mergers or dissolution.

We shall ensure that in case of disclosure of whole or part of the User's information to a service provider or agent, within India, the same shall be bound by obligations of confidentiality at least as strict as our obligations under this Privacy Policy and the

information shall be accorded the same level of protection as provided by us under the terms of this Privacy Policy. We may store the User's information through its vendors (for instance, on servers or databases co—located with hosting providers).

Happy never will sell or rent personal information of its clients to anyone, at any time, for any reason. We may use the User's personal information in the following ways, viz:

- Monitor, improve and administer the Website and improve the quality of services;
- Analyse how the Website is used, diagnose service or technical problems, maintain security;
- Remember information to help the User effectively access the Website;
- Monitor aggregate metrics such as total number of views, visitors, traffic and demographic patterns;
- To confirm the User's identity in order to determine its eligibility to use the Website and avail of the services;
- To notify the User about changes to the Website;
- To enable Happy to comply with its legal and regulatory obligations;
- To help the User apply for certain products and services.
- To respond to your queries o feedback submitted by you.
- To take up or investigate any complaints/ claims/ disputes.
- For the purpose of sending administrative notices, service related alerts and other similar communication with a view to optimising the efficiency of the Website.
- Doing market research, troubleshooting, protection against error, project planning, fraud and other criminal activity.
- To reinforce Happy's Terms of Use.

Access to personal information is strictly restricted and shared in accordance with certain specific internal procedures and safeguards that govern access. Certain features of the Website are available for use without any need to provide details. Other features of the Website may require Users to provide details including but not limited to the User's name, address, mobile number, email address, PAN No., employment & income details.

SECURITY OF INFORMATION

We use commercially reasonable safeguards to preserve the integrity and security of the Users' information against loss, theft, unauthorised access, disclosure, reproduction, use or amendment.

The information that is collected from the Users may be transferred to, and stored at, a destination inside India. By submitting information on the Website, the Users agree to this transfer, storing and/or processing. We will take such steps as it considers reasonably necessary to ensure that the Users' information is treated securely and in accordance with the Policy.

In using the Website, the Users accept the inherent security implications of data transmission over the internet.

Happy assumes no liability for any disclosure of information due to errors in transmission, unauthorised third party access or other acts of third parties, or acts or omissions beyond its reasonable control and the User agrees not to hold us responsible for any breach of security unless such breach has been caused as a direct result of gross negligence or wilful default of ours.

In the event Happy becomes aware of any breach of the security of the Users' information, it will promptly notify the Users and take appropriate action to the best of its ability to remedy such a breach.

EXCLUSION

This Policy does not apply to any information other than information collected by us through the Website including such information collected in accordance with the clause on "Collection of Information" above. This Policy shall not apply to any unsolicited information provided by the Users through this Website or through any other means. This includes, but is not limited to, information posted on any public areas of the Website. All such unsolicited information shall be deemed to be non–confidential and Happy shall be free to use, disclose such unsolicited information without limitation.

COOKIES

We collect certain information from the User's browser using small data files called "cookies." We use session ID cookies to confirm that customers are logged in. This type of cookie helps us to recognize a customer if he or she visits multiple pages on the Website during the same session, so that separate passwords are not required to access each page. The User may remove or block this cookie using the User's browser settings to disable the feature.

We also store transaction history. We may collect additional information in ways not specifically described herein. For example, we may track information related to interactions with customer service or responses from surveys or other feedback tools. We use this information to continually improve the service provided to the customers.

Our Policy does not cover the use of cookies by its partners and affiliates. We do not have access or control over these cookies. Our partners and affiliates may use session ID cookies to provide a custom user experience and to track the success of our partnership with them.

WEB BEACONS

The web pages of the Website contain electronic images known as "web beacons" (sometimes called single-pixel gifs) and are used along with cookies to compile aggregated statistics to analyse how the Website is used. Web beacons may also be used in some of Happy's emails to so as to know which emails and links recipients have opened, allowing it to gauge the effectiveness of its customer communications and marketing campaigns.
